- I am a former officer of the NSW Police Force. Prior to my retirement I held the rank of Senior Constable and performed duties as an Acting Sergeant.
- 2. On 1 May 2013 I signed and produced a statement in answer to a summons for production issued on 30 April 2013 by the Special Commission of Inquiry Into matters relating to the Police investigation of certain child sexual abuse allegations in the Catholic Diocese of Maltland-Newcastle.
- 3. Annexed to this statutory declaration at page 3 and marked "A" is a copy of that statement (May Statement).
- 4. This statutory declaration is made on the same basis as set out in paragraph 3 of my May Statement which is annexed to this statutory declaration and marked "A".
- 5. I refer to paragraph 5 of my May Statement.
- 6. At paragraph 5 of my May Statement I indicated that I supplemented the Information Report (the 2003 Information Report) referred to in that paragraph (being the Information report at Annexure "A" of my May Statement) with information which was recorded on the COPS System regarding Father Denis McAlinden. Attached to my May Statement was only the first page of my 2003 Information Report. Annexed to this statutory declaration and marked "B" is a complete copy of the 2003 Information Report.
- 7. I do not now have an independent recollection of all of the records which I reviewed on the COPS system at the time I authored the 2003 Information Report referred to at paragraph 5 of my May Statement.
- 8. I have refreshed my memory by reviewing a COPS audit report of my usage of COPS at and around the time that I prepared the 2003 Information Report. On the basis of that audit report and the recollection I do have of the entries that I reviewed in the course of preparing the 2003Information Report, I have identified COPS entries that I believe were reviewed by me when I prepared the Information Report and marked those entries as Annexures to this statutory declaration as follows:
 - (a) CNI 698137577 Annexure "C";
 - (b) Information Report Summary 17885027 Annexure "D":
 - (c) Information Report Summary 125303696 Annexure "E";
 - (d) COPS Event Reference E8026529 Annexure "F".
- Relevantly, Annexure C has been amended since the date that I prepared my 2003 Information Report 15 and 16 May 2003. Additionally, a number of the events

- 10. In the course of preparing the 2003 information Report I also consulted the National Names Index. A copy of the entries that I reviewed on the National Names Index is annexed to this statutory declaration and marked "G".
- 11. I have been shown Event number E14348559 which is a COPS event in relation to allegations against a priest, Father James Fletcher. COPS Event Number E14348559 is annexed as Annexure "H" to this statutory declaration. I have been shown the COPS audit report that indicates that I reviewed the COPS Event that is marked Annexure H immediately before I reviewed material in relation to Father Denis McAlinden on 15 May 2003.
- 12. I am informed by solicitors for NSWPF that Father James Fletcher is a priest who is relevant to this inquiry's Terms of Reference. I have been informed by solicitors for NSWPF and verily believe that Father Fletcher was charged with a number of offences on 14 May 2003 at Newcastle Local Court.
- 13. I do not recall having any knowledge or involvement in any investigation involving Father Fletcher nor can I recall him as having relevance to the Intelligence Report. To the best of my recollection, sexual assaults, including historical sexual assaults, were classified as a "Significant Events" on COPS and to the best of my recollection I would have I reviewed this COPS event by as part of my usual review of matters classified as having "Statewide Significance" rather than for the purpose of preparing the 2003 information Report.
- 14. The May Statement and this statutory declaration are true and correct.
- 15. I make this solemn declaration conscientiously believing it to be true, and by virtue of the provisions of the Oaths Act 1900.

Statement of Kylie Maree Gronin

Special Commission of Inquiry into matters relating to the Police investigation of certain child sexual abuse altegations in the Catholic Diocese of Maltland-Newcastle

On the 1st May 2013, I say:

Prefiminary matters

- 1. My full name is Kylle Maree Cronin.
- 2. Between 1996 and 2006 I was an officer of the NSW Police Force and for most of this time I was attached to the Kings Cross Police Station. During my period of service with the NSW Police Force I was seconded to Rose Bay Police Station as an Acting Sergeant for the intelligence unit for approximately one year. I attained the rank of Senior Constable before resigning in 2006 after a period of maternity leave. White working at Rose Bay and Kings Cross I performed duties as a General Duties Officer and an intelligence Officer.
- 3. This statement is prepared by me for the sole purpose of responding to a summons dated 30 April 2013 by the Special Commission of inquiry (established by way of letters patent dated 21 November 2012 and varied by letters patent dated 25 January 2013) for me to produce a statement in relation to a number of defined issues. This statement is produced by me to the Special Commission of Inquiry pursuant to the said issued summons unwillingly and only on the basis that, without exception, section 23(2) of the Special Commissions of Inquiry Act 1983 applies to restrict the use of this statement and the documents referred in it, and attached to it. Pursuant to section 23(2) of the Special Commissions of Inquiry Act 1983 I object to the Information contained within this statement, and the attachments to the statement, being used in any criminal, civil or other proceedings or inquiries or investigations of any kind.
- 4. This statement primarily relates to the information and background to information Report Number I 17256624 (Information Report) that I completed on the NSW Police Force's electronic systems. A copy of that report is annexed to this statement and marked as annexure "A".
- 5. I authored the information Report after I visited my family who live in Merriwa. I grew up in Merriwa and the content of the information in the information Report is derived from my discussions with members of my family, friends and acquaintances in the area. The Information Report is also supplemented by Information which was recorded on the COPS computer system regarding Father Denis McAlinden.
- 6. In the information Report it is shown that the "source" of the information in the Report came from the "general public" with the "reliability" being "c" which means from memory, that the information was possibly supplied from hearsay sources. Further, that the "validity" of the information was "probably true", being on a scale of "2".
- 7. Mentiva is a very small country town.

- 8. The persons that this information was about are either persons I knew or were acquainted. They are all from the small country town of Merriwa where some of my olose relatives and friends still reside. I do not feel comfortable in disclosing these persons' names in a document which may become public because these persons did not personally approach me in relation to any alleged abuse nor did they make any complaint to me in relation to any alleged abuse. Further, some of these people may not wish to disclose that they had been abused for a number of reasons and I do not wish to re-victimise these people. I am also unaware if any of these alleged victims have come forward and have willingly provided information to the Commission. If required to and forced to by law, I am prepared to disclose the names of these people but only in a private sliting of the Commission on the assurance these names will not be made public.
- One of the numerous people with whom I spoke to before preparing the Information Report which appears in Annexure "A" was Kevin Adams. I would like it to be made clear that Kevin Adams did not discuss with me any of the sileged victims referenced in paragraph 8. During the course of my conversation with Kevin Adams he told me words to the effect that he or someone or some people that he knew had seen Father McAlinden in Muswellbrook "recently". While I did not know precisely the time frame Mr Adams was referring to, I thought that the observation of Father McAlinden's whereabouts was relevant to the information Report as there was an outstanding first instance warrant for Father McAlinden's arrest and Father McAlinden's police profile suggested that he had left Australia but fater returned to Western Australia.
- 10. As an Intelligence Officer I had access to state shared information systems regarding interstate charges and information and warnings on dangerous and/or outstanding offenders. While I cannot clearly recollect precisely how I came to know of Father McAlinden's interstate charges I assume that the reference in the information Report that the "POI has also been charged in Western Australia for child sex offences" was based on the information made available to me as an intelligence officer.
- 11. Similarly, I did not have any first hand knowledge of there being "two further cases involving different victims" and assume that there was some reference to other victims in Father McAlinden's police CNI profile at this time to other victims.
- Annexed to this report and marked as Annexure "B" is a report in relation to the history and dissemination of the information Report. After completing an information Report if is evaluated by an infelligence Officer. Evaluating Officers are responsible for reviewing information reports and ensuring that the report is acted upon locally and/or disseminated to the relevant sections of the NSW Police Force. In this instance a copy of the infelligence Report indicates that Andrew Clark, who was one of my colleagues at Rose Bay, evaluated the information Report end disseminated it to (i) SCC Sex Crimes Squad Intelligence; and (ii) the Hunter Valley. It appears the report was also automatically disseminated to the State Crime Command Sex Orimes Squad as it was an information Report that appears to be part of the 'CPEA Collection Plan 2001'. The intelligence history in Annexure "B" indicates that Gregory Brian Englert (SCC Sex Crimes Squad Intelligence) and

Kate Elizabeth Williams (Hunter Valley LAC) were the reviewing officers of these disseminations.

- 13. When I was in sixth class at school Father Denis McAlinden became our parish priest and priest to my primary school. I personally was not one of Father Denis McAlinden's victims but tooking back with the benefit of hindsight and my training in the police force I can see that his behaviour was the type of behaviour which might make someone suspicious of inappropriate behaviour around children.
- 14. On one occasion I recall Father McAlinden offering to take me to a regional swimming carnival in Lambton and to buy me new shoes for my upcoming confirmation. While we were at this swimming meet Father McAlinden came into the girls' change room and started chatting with the girls whilst lithey were in various states of undress. It was only when a ledy came into the change room that he left. I recall that Father McAlinden often offered to take girls to sporting and other events in his white van, such as our weekly inter-school sports excursions to Sandy Hollow and Caselils.
- 15. I also recall when I was at school that Father McAlindan had ioliles which he handed out in the playground, particularly to the younger girls. After I left primary school, **REMATER** I, who is two years younger than me (and three school classes below me), told me that she used to sit on Father McAlindan's tap during confession as did many of the girls. **REMATER** also told me that they were told not to go to the church alone and that the prasbylery was out-of-bounds. She told me the teachers told her that. I am unsure as to which teacher's that was.

The victim alleged that threats were made by the priest that he would commit similar offences against the victim's younger brothers should he

disclose the offences.

The victim later left to live in Tasmania & over the years has come to terms with these offences, gradually disclosing them to his family and a counsellor.

After watching the 60 minutes programme on 2/6/02 the victim was concerned that others could become victims of the same POI & has decided to report the matter to Police.

It is alleged the offences occurred in the Clarencetown & Dungog areas whilst the victim was an alter-boy.

CENTRAL HUNTER - FOX, PETER RAYMOND In 1985 the defendant, James Patrick FLETCHER arrived in the Dungog Parish as the new Catholic Priest. He worked at both the Dungog & Clarence Town churches & there met the victim's family.

Through this working relationship the defendant developed a close friendship with the family becoming a regular visitor to their home for meals & invited to family parties & celebrations. Over time he became a mentor for this family's children, including their eldest son & victim,

. : AH & his other siblings later became altar boys within the parish creating an even stronger bond.

The victim aged 12, started at St Peter's High Maitland in 1990 & was occasionally driven home by Father FLETCHER. Over this period conversations occurred between the two in relation to sexual education & masturbation with

January 1990-1 whilst travelling between churches with AH , Pather FLETCHER removed his penis & commenced to masturbate. He encouraged AH (Then aged 13) to do likewise. Again it was emphasised that this was to remain a secret & not be discussed with any other person, especially: AH 's parents. Further conversation occurred in 1991 when the victim was further spoken to about sexual matters by Father FLETCHER. In March 1991 Father FLETCHER drove AH after school to the Walka Water Works reserve. He removed his penis & encouraged the victim to perform oral sex on him. The victim was told that this was normal behaviour & given on the pretext of sexual education. The victim's head was held in place by Father FLETCHER until he ejaculated in the victim's mouth, at which point the victim began to dry-wretch. Father FLETCHER reinforced that this remain a secret. He said to the victim, "It's normal & its a natural part of life. A lot of people do it but it is to just stay between you & me. No one else should know about this, it is our secret. You won't mention this to your parents or anyone else will you?" & "You know your father probably did exactly the same thing & he still keeps it a secret." These assaults then began to occur on a regular basis with the victim being forced to perform oral sex on Father FLETCHER a further 4 times in early 1991. In June 1991 Father FLETCHER again picked the victim up from school but instead of driving to the Walka Water Works he drove to a park on the outskirts of Paterson. He parked in a secluded area near the river where he performed oral sex on the victim. After the victim failed to have an erection he was asked to get out of the car & removed his school pants. Father FLETCHER then forced his penis into A-H s anus whilst the forced his penis into child braced himself in pain against the side of the vehicle. After ejaculating Father FLETCHER comforted AM: who was sobbing telling him, . "That's okay. Its only natural. It will stop." He again emphasised that these incidents should remain a secret. His demeanour changed on the drive back into Maitland when he saw the distress the child was in. He said, "If anyone finds out about this I am a priest. Everyone knows that priests don't lie. They won't believe you. Remember you have three brothers & if you tell anyone I could hurt them too." Assaults of both anal & oral intercourse continued in various forms & locations over the

next 3 years until March 1994 when the victim was old enough to prevent any further occurrence following a major confrontation between Father FLETCHER & himself. Over the four year period a total of 56 offences occurred. The victim experienced a lot of difficulties in dealing with these offences & in September 1995 after a heavy bout of drinking he attempted to hang himself in a shed on his parents rural property. His mother & young brother located him whilst this was occurring & lifted him down after he had been hanging for a short period. In desperation to find answers the victim's parents (Unaware of their son's reasons for depression) took him to see the family priest who was now located at Branxton. He stayed in the presbytery that night & believes he was raped whilst in a vulnerable state. This was the last occasion he had any contact with Father FLETCHER. The victim has led a troubled life since that time until disclosing to his family in late 2000. In June 2002 he was encouraged to approach Police with his allegations & investigations commenced. Police learned that Father FLETCHER had been notified of the Investigation by a member of the Catholic Church & was permitted to continue his duties in the Branxton Parish. Investigations continued over the next year & in March 2003 Father FLETCHER was stood down from the Branxton Presbytery. Police contacted members of the church & Father FLETCHER presented at the Maitland Police Station on Wednesday the 14th of May 2003 with solicitor Eric LACEY & a support person Father Jim SAUNDERS. FLETCHER emphatically denied the allegations of sexual misconduct & disputed other matters pertaining to the investigation.
