Hanley information told Harrigan that ?had received information. He had previously been at Lochinvar presbytery and that James Fletcher later showed persons that he allegedly located homosexual and pornographic videos and magazines. Asked did these belong to you or Fletcher? Stated "they were mine". I said "are you sure?" He said yes. I said: do you have them? Did James Fletcher hand them back to you? Stated yes he did and I have destroyed them. When is this all going to stop? It has hurt a lot of people. I said I would expect James Fletcher's trial about mid 2004. I said I am sorry for any hurt or embarrassment this has caused you. Have you ever seen any similar material in possession of Jim Fletcher. " I suspect he had some but I never saw him with it".
