Statement of Jacqueline Leonie Flipo

Special Commission of Inquiry into matters relating to the Police Investigation of certain child sexual abuse allegations in the Catholic Diocese of Maitland-Newcastle

On 16 May 2013, I say:

Preliminary matters

- My full name is Jacqueline Leonie Flipo and I am a Detective Senior Constable with the NSW Police Force.
- 2. This statement is prepared by me for the sole purpose of responding to a summons dated 6th May 2013 issued on 6th May 2013 by the Special Commission of Inquiry by the Special Commission of Inquiry (established by way of letters patent dated 21 November 2012 and varied by letters patent dated 25 January 2013) for me to produce a statement in relation to a number of defined issues. This statement is produced by me to the Special Commission of Inquiry pursuant to the said issued summons unwillingly and only on the basis that, without exception, section 23(2) of the Special Commissions of Inquiry Act 1983 applies to restrict the use of this statement and the documents referred in it, and attached to it. Pursuant to section 23(2) of the Special Commissions of Inquiry Act 1983, I object to the information contained within this statement, and the attachments to the statement, being used in any criminal, civil or other proceedings or inquiries or investigations of any kind.

Background

3. I was attested as a police officer on 26 April 1991. After my date of attestation, I carried out general duties policing work for a period of approximately two to three years. Thereafter, I was engaged with the Special Operations Group for a period of approximately 18 months. After carrying out my duties with the Special Operations Group, I then returned to carrying out some general duties policing work and took an "A listing" position. This involved me carrying out plain clothes duties policing work as a constable. I later attained a permanent plain clothes position. I carried out these duties which involved investigation work including matters such as sexual assaults, robberies and murders. I was designated a detective in 2001 and since that date, have carried out those duties in the Lake Macquarie Local Area Command.

Involvement with UC3 and McAlinden matters

- Annexed hereto and marked with the letter "A" is a copy of a COPS Event (the COPS Event) entry relating to complaints made by AF with respect to a persons of interes' 'UR3 and Father Denis McAlinden. For identification purposes, the COPS Event reference is E 11302712.
- 5. I first became involved in the U2-3 and McAlinden matters, to the best of my recollection, in or about July of 2001. After the creation of the COPS Event the case was sent to the Lake Macquarie area by way of hard copy documents. At the time, I was working as a detective within the Lake Macquarie Local Area Command. Upon receipt of the documentation, I had responsibility for carrying

out investigations in relation to the complaints made by AF As part of my investigation I was required to contact. AF has well as potential witnesses. I was also required, once sufficient information was obtained and once I was satisfied that there was sufficient information so as to warrant my investigating the whereabouts of each of the alleged perpetrators, to make inquiries for the purpose of contacting them.

- 6. To the best of my recollection, I commenced making inquiries of the police computerised information system as to the whereabouts of I () (23e and Father McAlinden. Those inquiries were not successful as there was insufficient information as to the current whereabouts of those persons. I later became aware as a result of information received, that I () (23) I had in fact passed away in the year 2000.
- Annexed hereto and marked with the letter "B" is a true copy of a case report, being C 12089827 (the Case Report). This Case Report was maintained in relation to the investigation carried out with respect to the AF matter. I refer to the handwritten notations contained within the Case Report, and I can confirm that the handwritten notations at pages 1 and 2 are entries made by myself. The dates referred to indicate the dates that the inquiries referred to were actually made.
- 8. Annexed hereto and marked with the letter "C" is a true copy of a document with the date 29 August 2002 in the top right-hand corner. The handwriting contained on the document is mine. I can confirm that the handwriting contained on the document was made on 24 September 2002 and reflects the information which was received by me on that date. This entry indicates that on 24 September 2002, I made contact with the Catholic Diocese so as to make attempts to locate the current whereabouts of Father McAlinden. On that occasion, I spoke to a person called Elizabeth, who I understood to be the Bishop's secretary. Elizabeth advised me that Father McAlinden had not been in the diocese for a period of about 10 years. The last address known to the diocese was through or care of a relative's address in London. Elizabeth advised me that she would speak to the Bishop so as to clarify if there were any further records kept relating to Father McAlinden's whereabouts. To the best of my recollection, I did not receive any further information relating to Father McAlinden's whereabouts from the Diocese, and at this stage I cannot recall whether I made further inquiries of Elizabeth in relation to Father McAlinden's whereabouts.
- 9. On 26 September 2002, I caused inquiries to be made through the police Field Services. Annexed hereto and marked with the letter "D" is a facsimile coversheet addressed to the Commander of Field Services in which a request to use iAsk was made. Attached to that facsimile is a report prepared by myself on 26 September 2002, requesting for inquiries to be made with the Registry of Births, Deaths and Marriages regarding the possible death of Father McAlinden.
- 10. Annexed hereto and marked with the letter "E" is a true copy of a document received from the Department of Immigration, and Multicultural and Indigenous Affairs relating to the iAsk inquiry made. The document is addressed to the Commander, Field Services, Information and Intelligence Centre of the NSW Police Service. That document, dated 8 October 2002, was referred on to me and maintained by me in the records maintained for the investigation.

- After receiving the document from the Department of Immigration, and Multicultural and Indigenous Affairs, I continued to undertake further inquiries in relation to Father McAlinden's whereabouts. Annexed hereto and marked with the letter "F" are two pages containing my handwriting, setting out the further inquiries that were made by me. The documents which are photocopied and contained within Annexure F are, to the best of my recollection, post-it notes which were kept by myself relating to my inquiries. As a result of my further inquiries. I was eventually able to locate Father McAlinden's sister,

 UL 18 On 28 April 2002, I was able to speak with her. Annexed hereto and marked with the letter "G" is a true copy of page 96 of the entry made in my police notebook at the time.
- 12. After I received information that Father McAlinden may have been in the State of Western Australia, I caused further inquiries to be made through Sergeant McSpadden, the person in charge of the NSW Police Lake Macquarie Intelligence Office at the time. The results of inquiries made of Western Australian police indicated that there were no current records maintained by that police service in relation to the whereabouts of Father McAlinden.
- 13. After these inquiries had been carried out, I was unable to ascertain the then whereabouts of Father McAlinden. My role thereafter was to assist the victim in making an application for victim's compensation with respect to the alleged crimes perpetrated upon her.
- During the period when I was carrying out the investigation with respect to the

 Allegations, it is also my belief that I caused to be placed on the
 police computerised information system the fact that Father McAlinden was
 wanted for the purposes of questioning in relation to the
 Allegations. To
 the best of my recollection, no information was forthcoming from any other police
 officer, suggesting that such a police officer had any further or ongoing contact
 with Father McAlinden.
- 15. To the best of my current memory and recollection, and based on the documentation available to me at the time of my preparation of this statement, I have set out all relevant information relating to my attempts to ascertain the whereabouts of Father McAlinden during the period of time when I was responsible for the investigation.


